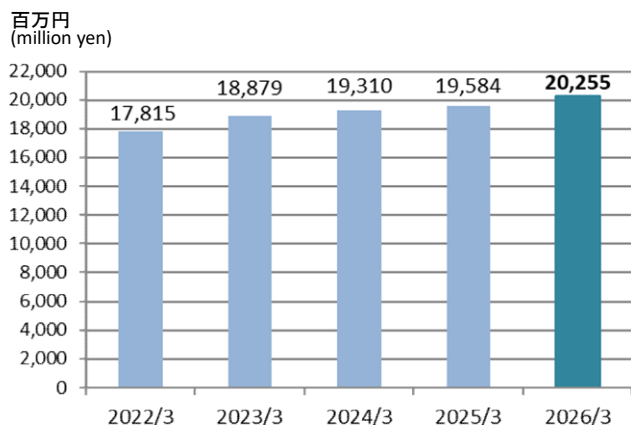

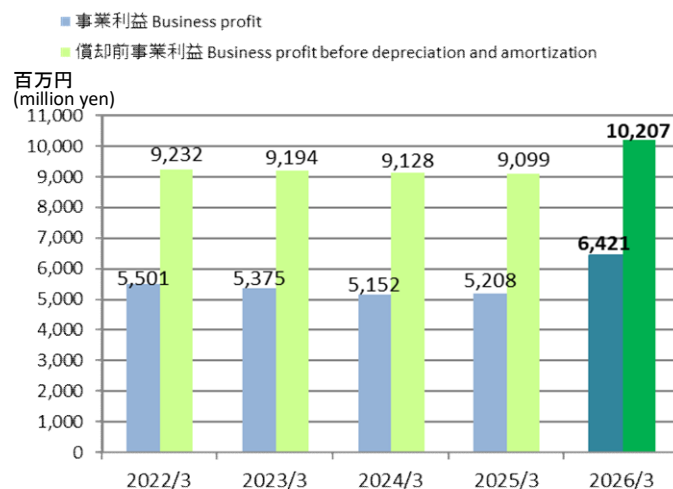

Net sales



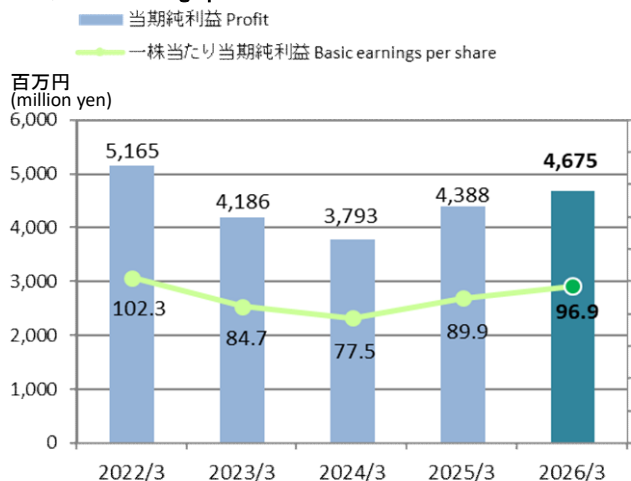
## 事業利益 / 償却前事業利益

Business profit / Business profit before depreciation and amortization



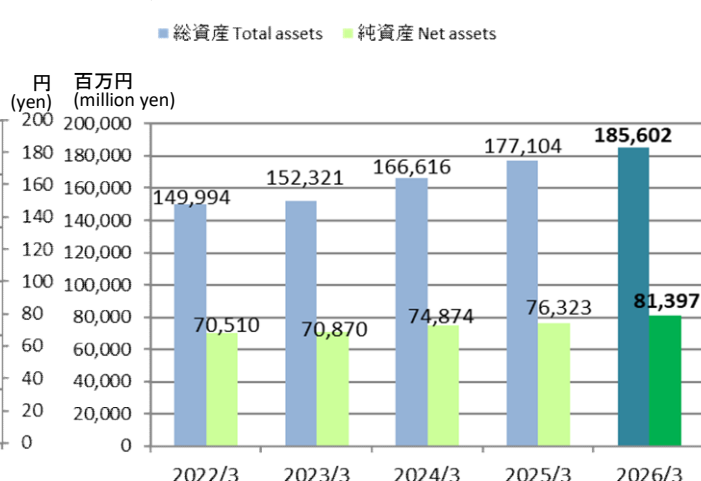

Profit/Basic earnings per share



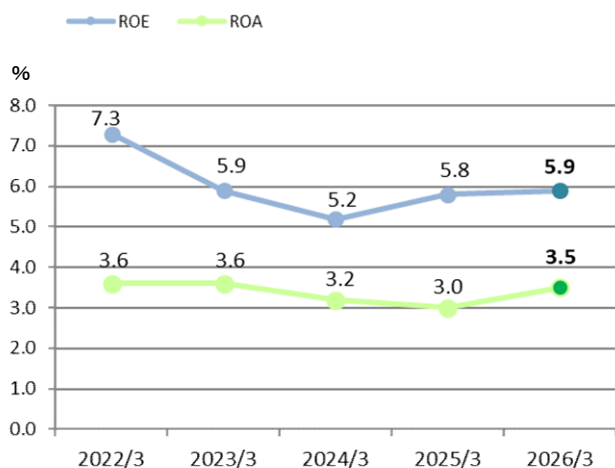

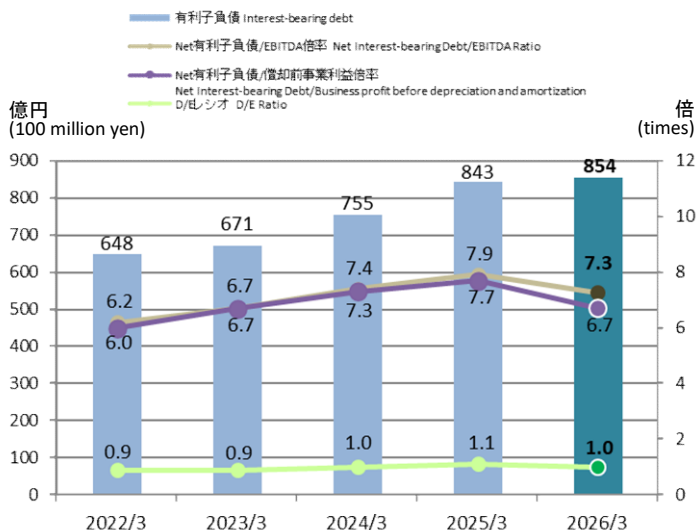

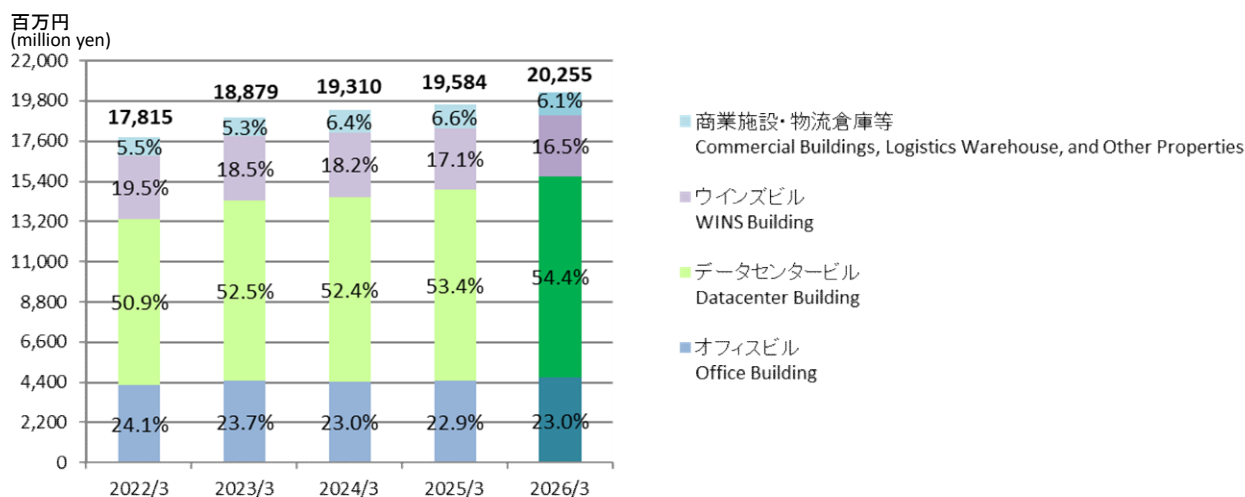

### Sales by Asset Type



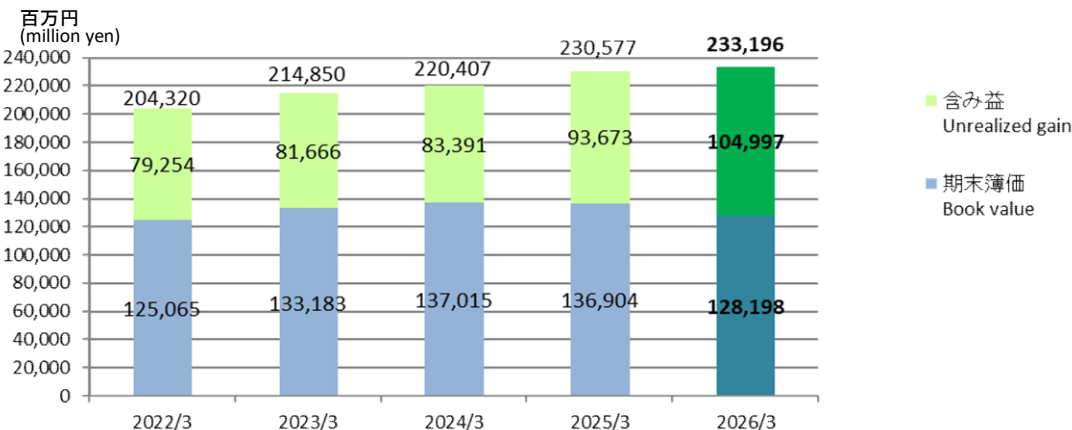

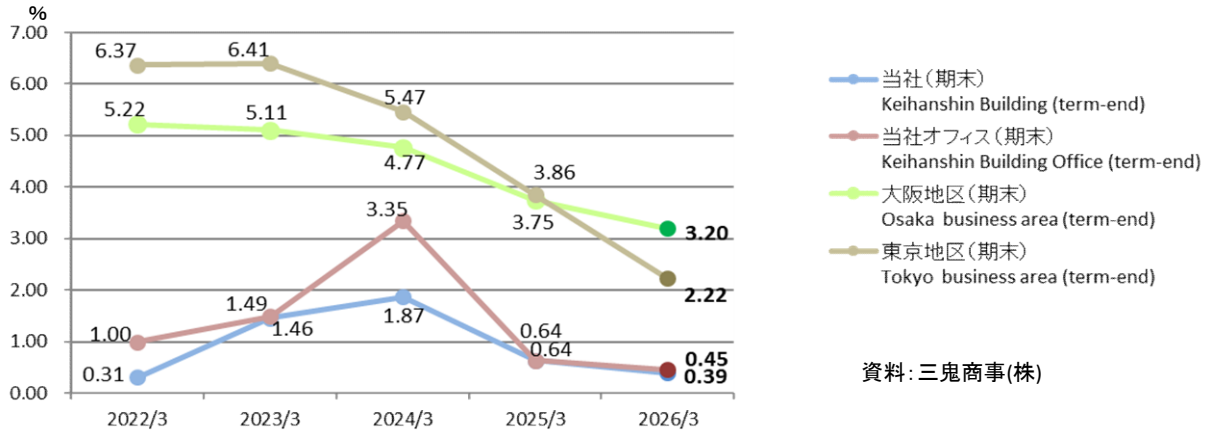

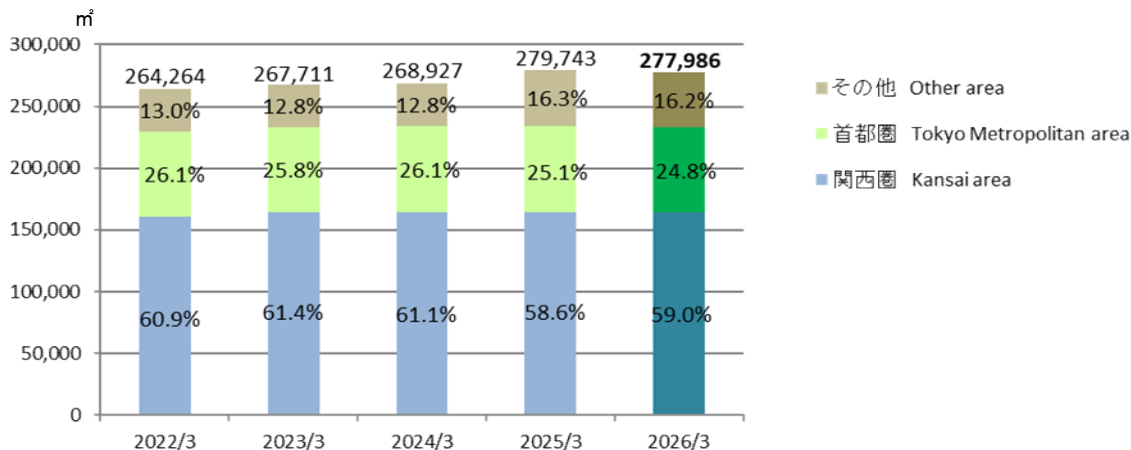
